Via a clearance procedure (THIS IS MANDATORY)

CONTENT:

- **presenting** the results to the responsible project team or task force,
 - should be available via video conference for the community
- **PROPOSAL to PIs:** we set a page on seminars
- **Uploading** the document to the electronic **pinboard:**
 - opened for internal discussion, less discussions with the referees.

 - **Copyright:**
 - Permission to publish framework agreements
 - Figures printed in black and white
 - The preprints will be stored on a preprint server (if requested figures as well)

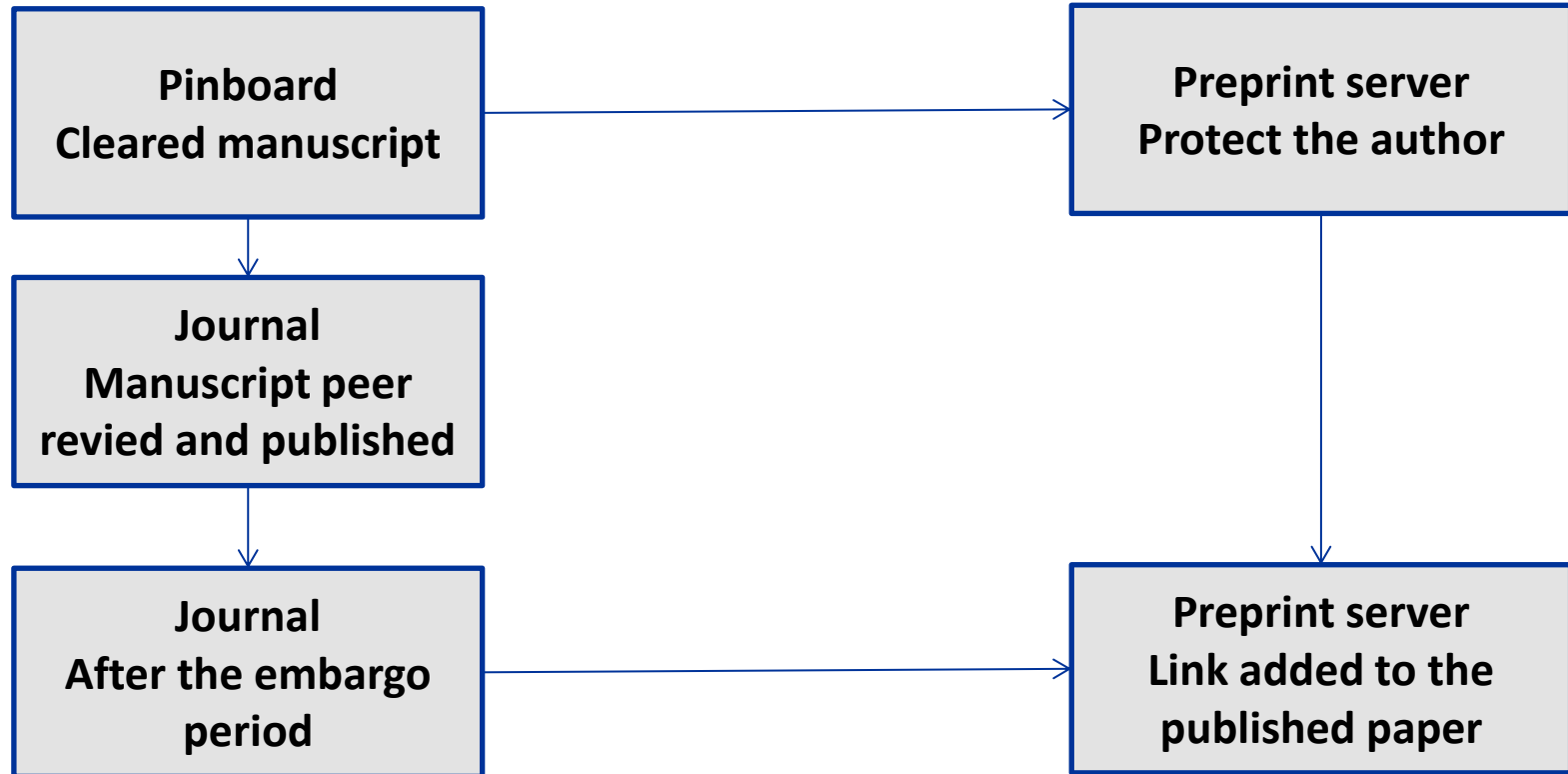

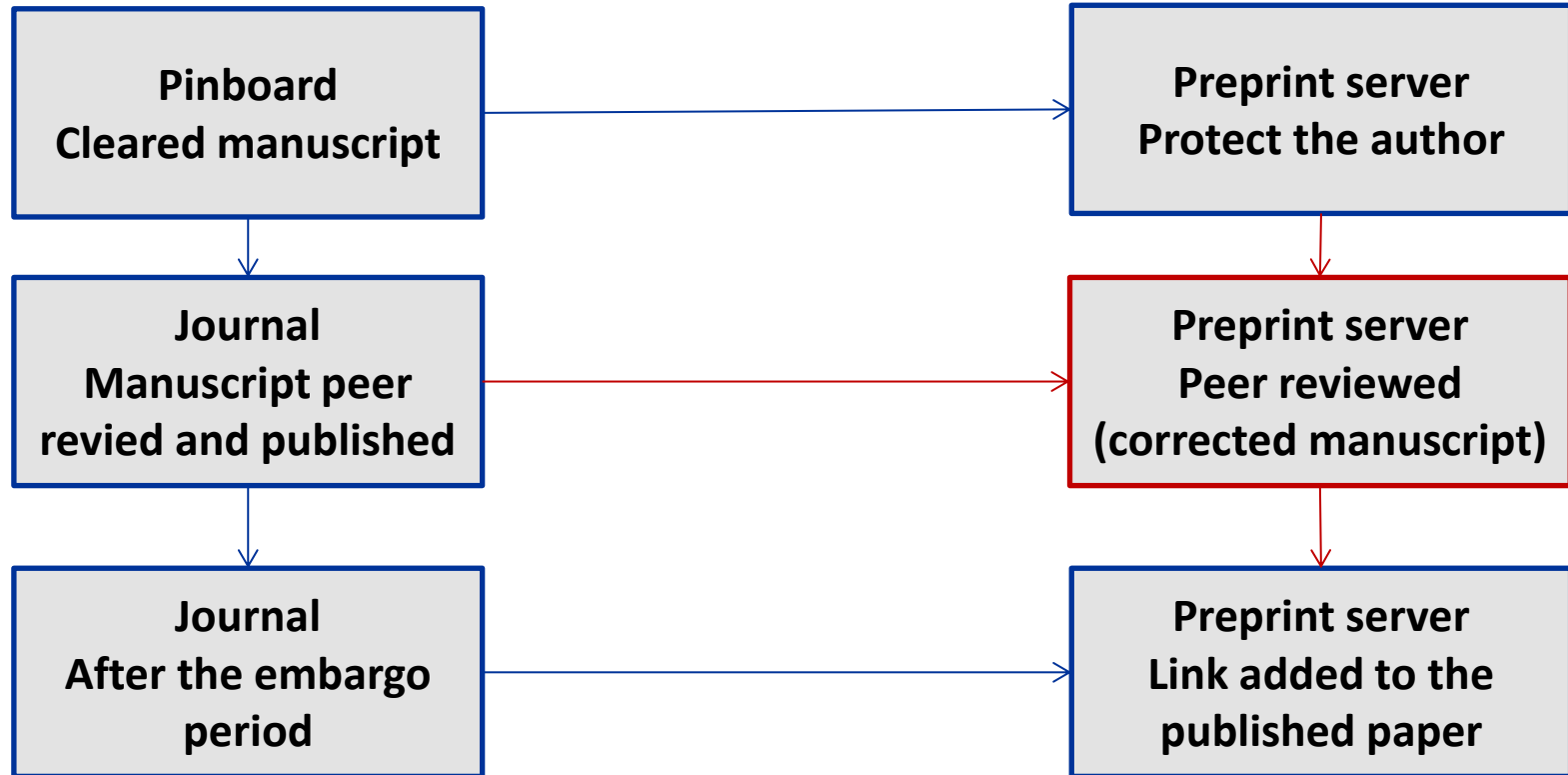


- **Green route- EUROfusion policy**
 - The peer-reviewed, corrected manuscript version made open access via our preprint server
 - Free of charge
 - We are trying to agree with the publishers
- **Golden route**
 - The journal makes open access the publication
 - **Only in exceptional cases**
 - Costly

Who should use the templates (decided by GA)

- PMU staff / Task Force Leaders / Project Leaders / Work Package Leaders / Principal Investigators are obliged to use the EUROfusion templates. The templates should also be used for JET publications; i.e. when the majority of the work has been performed using JET data. In all other cases, Research Unit staff is allowed to use the templates of their own organizations. However, in case the work is also (partly) funded by EUROfusion, of course the EUROfusion logo, the European flag as well as the acknowledgement have to be included.
- **Note:** Principal investigators should use the EUROfusion templates when they are acting in this role, more precisely when they present results emerging from their enabling research project. In case only a minor part of the presentation is connected to the project, principal investigators can use the template of their own organizations including the EUROfusion logo, the European flag as well as the acknowledgement.



- An electronic **EUROfusion pinboard** will be used, based on the software already used on JET, allowing to upload draft publications in advance of their submissions to Journals or Conferences.
- The use of the pinboard **necessitates a JET account** should be provided to all EUROfusion members.
